- 3. <u>DIRECTOR OF HUMAN RESOURCES' REPORT</u>: The report was provided for the Committee's information. Mrs. Amadio reported that nothing much happened this month. There is nobody on Short Term Disability currently and nobody on Worker's Comp. DELCORA did do the United Way Campaign this year. We did it a little differently this year. The campaign was only for five days and it was done through email and the internet. We still got a nice turn out from our employees. Once we get those documents back, the close-out will be placed on the O&E and Board agendas for close-out approval. The item listed under Miscellaneous "various regulatory reports" are monthly, quarterly, semi-annual or annual reports that are completed by Engineering or Operations and then sent to the Admin team to finalize, scan, copy and mail out. The remainder of the report lists the other routine items the Admin team processed. Ms. Bonnett had no additions or changes to her written report. The Committee had no questions or comments to the written report.
