 - SAS SYSTEM HAS BEEN UPGRADED AND IS PERFORMING WELL.
 - RISK MANAGEMENT PLAN BEING UPDATED FOR AUDIT PURPOSES.
 - EPA CHLORINE AUDIT HAS BEEN COMPLETED AND SENT TO EPA FOR EVALUATION. WE JUST RECEIVED FEEDBACK FROM EPA WITH ADDITIONAL INFORMATION REQUESTS WHICH ARE BEING ADDRESSED. EPA ADVISED THAT THEY WILL BE ONSITE FOR AN AUDIT ON JANUARY 20, 2022.
 - OPERATIONS MEETINGS ONGOING WITH PERSONNEL IN EVERY SHIFT. ALL FOREMAN HAVE BEEN INTERVIEWED AND GREAT INPUT HAS BEEN GIVEN.
 - CHESTER RIDLEY PUMP STATION IS BEING USED TO HOUSE SEWER MAINTENCE VAC TRUCKS DUE TO FREEZING CONDITIONS.
 - ALL TRUCKS FROM THE BONEYARD HAVE BEEN REMOVED
 - ADOBE YEARLY LICENSE RENEWED, WEBTITAN HAS BEEN RENEWED FOR THE YEAR AS WELL, THIS IS A CLOUD BASED WEB FILTER USED TO PROTECT OUR COMPUTER SYSTEM.
 - SAFETY COORDINATOR IS SETTING UP YEARLY REFRESHER TRAININGS FOR EMPLOYEES WHICH I WILL GO OVER WHEN RECEIVED.
 - SNOW EMERGENCY TEXT SYSTEM IS IN PLACE AS WELL AS THE CALL IN NUMBER #155. BOTH HAVE BEEN TESTED AND VERIFIED.
