- WORK IS COMPLETE WITH OUR INSURANCE CARRIER TO INSURE DELCORA IS PROTECTED AGAINST ANY TYPE OF CYBER THREATS.
- NEW POLICY PROCEDURES ARE BEING IMPLEMENTED FOR CYBER SECURITY. THESE SAFEGUARDS WILL BE INTRODUCED AT A MODERATE PACE FOR TRAINING PURPOSES. PHASE ONE HAS STARTED AS OF FEBRUARY 1, 2023.
- I REACHED OUT TO DELAWARE COUNTY EMERGENCY SERVICES AND CHESTER FIRE DEPT TO DISCUSS TOURING OUR FACILITY AND SHOWING THEM OUR CHLORINE SYSTEM FOR OUR RMP PROGRAM. VERY POSITIVE NEWS CAME FROM THIS DISCUSSION. WE LEARNED THAT CFD AND THE COUNTY ARE NOW CERTIFIED AND TRAINED FIRST RESPONDERS FOR CHLORINE INCIDENTS. WE ARE PLANNING TO HAVE A MOCK EMERGENCY DRILL WITH CFD IN THE NEAR FUTURE, THIS IS A GREAT OPPORTUNITY FOR US TO COORDINATE WITH LOCAL AUTHORITIES.
